Absent: McLean


Purpose: For 1970 Budget hearing.

The Council was in session one hour during which time no tax payer appeared, nor were there any oral or written objections to the proposed 1970 budget.


Motion by Friday, second by Miller to adopt the budget as published and instructed the Mayor and Clerk to certify the proposed estimate and forward the same to the County Auditor.
