Motion by McLean that LeRoy Miller be hired for Street Commissioner, Water and Sewer Superintendent and Deputy Policeman at \$520.00 per month with two weeks paid vacation. Second by McLean. Carried. Oath of office taken.

Motion by McLean to appoint Clapsaddle & Garber Associates as the Town of Conrad Engineers for 1970 & 1971 to be used when their services are needed. Second by Beeghly. Carried.

Councilman Metge introduced the following resolution and moved its adoption. Second by Councilman McLean.

Detoxification center at Iowa Falls, Iowa was discussed. No action taken.




